COLLECTION OF PERSONAL INFORMATION AND OTHER INFORMATION

“Personal Information” means data that identifies an individual or relates to an identifiable individual.

We collect Personal Information through various Activities and Interactions. In conducting every aspect of our business, we may collect Personal Information. We also collect Personal Information when you use, visit or participate in the Activities and Interactions. Such information may include, without limitation: your first, middle and last name; home and mailing addresses; email addresses; telephone numbers; credit or debit card number or other payment method; billing information; and other types of Personal Information that you choose to provide to us or that we may obtain about you.

We collect Personal Information at various places and through various mechanisms when you use, visit, or participate in the Activities and Interactions.
